

New important book



Neurocognitive Rehabilitation of Down Syndrome: Eearly Years

by Jean-Adolphe Rondal, Juan Perera, Donna Spiker.

Juan Perera presented this new book in Rom. It has been published after the International Conference on Early Intervention in Palma de Mallorca, 2008. This book describes how early cognitive intervention in children with Down syndrome can be carried out, and can reduce, or compensate for, the major deficits characteristic of the condition. This comprehensive account relates the neurocognitive approach to the major therapeutic endeavors in the neighboring fields of neurogenetics, experimental environmental enrichment, molecular genetics, pharmacology, pediatrics and cardiology for infants with Down syndrome. Neurocognitive Rehabilitation of Down Syndrome provides the guidance required to establish effective rehabilitation programs, and is essential reading for developmental clinicians, pediatricians, neuropsychologists and other health professionals.
