# "DISCIT - making persons with disabilities full citizens"

Anna Contardi, as EDSA President, was contacted by EU Framework 7 research consortium DISCIT in order to be interviewed on the role of European Disabled People's Organisations in processes of deliberation, decision and implementation of disability policy at the European level and with special regard to the United Nations Convention on the Rights of Persons with Disabilities (UN-CRPD).

The research consortium DISCIT aims to produce new knowledge enabling member states, affiliated European countries and the European Union to achieve full and effective participation of persons with disabilities in society, policy making and the economy.

One main feature of DISCIT is close collaboration with Disabled People's Organisations on different levels throughout the whole project (www.discit.eu).

Expert interviews are focused on the Internationalisation of Disability Politics.
